There are some concerns with many areas in the collective agreement which does not make sense to us. There were hot issues that members in the York Region raised with regards to Article 41 in particular regarding the seniority issue.

This is an opportunity for us to voice opinions and be heard when the time comes, therefore, please begin to formulate your respective submissions to be sent in to the York Branch. Our concerns are important and we need those areas of concerns resolved or addressed. What usually happen is we do not send in our concerns to the Local to be sent in to the negotiation team, but we complain after the agreement is in place and we are not satisfied with the content. A recent example is the York Region has the largest membership in APOC. A news letter was sent out informing our members to forward their concerns and changes if any with regards to the APOC National Constitution to be discussed at the APOC National Convention in June 2013. There was not even one response from our members in the York Branch. If we do not take the time to read the correspondence coming from the APOC Executives, we will not be able to keep up with the changes that need to be made in a timely manner. Other Regions submitted a lot of very valid proposals for changes in the APOC National constitution which will be discussed at the Convention in June 2013. York Branch has none. On the matter of the Collective Agreement, the APOC National will be sending out a communications to inform about the upcoming negotiations on our collective agreement. Please pay attention to correspondence from the National office so that we do not miss out on the opportunity to reform our collective agreement. We all constitute APOC and we can make it a better Association if we constructively participate in meaningful discussions moving forward. I will encourage you not to think about the past but rather the future. Bring your ideas and concerns forward when the opportunity arises for us to negotiate our Collective Agreement later this year.
