

The results of our elections to complete our executive team will be presented during our September 17th, 2023, general meeting. I hope you took the opportunity to have your vote be part of a renewed membership. I encourage you not to stop at casting your vote, come out to the general meetings and drive the changes you discuss in the depots. SSD is the direction of the corporation which includes significant changes to all delivery positions!

No National SSD standard outlining the impact to APOC has yet to be communicated locally, APOC start times are being affected with little to no advance notice. Various depot profiles are surfacing on how and where the router positions will roll up when insufficient router positions are created to add a router supervisor position. CPC local management has opted to prioritize their efforts to communicate and stabilize the changes impacting CUPW members while delaying and not being forthcoming with the changes impacting APOC.

PCR East has initiated a new look when sending the weekly APOC staffing forecast. This provides a more complete look of the staffing situations allowing a more informed discussion during consultation. The National employee survey will be taking place during September 2023, this remains one of the most direct opportunities for your voice to be heard by CPC senior management.

I finally have good news regarding the 9 Pager for IMS logs. This document is no longer mandatory for us to complete. The corporation is requesting all new supervisors to use it as a guide when completing an IOD investigation.

The Corporation is starting to question the number of employees that are swiped into material handling and dock. Please make sure you check the ZWAME report to ensure that your employees are swiped into the correct process as I believe they will be monitoring this. If you are receiving 100% on the ZWAME report but your employees are swiped into the wrong cost centre this will be very challenging to explain and could lead to discipline, if you are not able to provide a reasonable explanation as to why.



Employee surveys is a chance for us to have a voice to address some of the issues we face daily. I encourage all of you to take the time to complete this year's survey which will be available to APOC on September 5th. We can't influence change or improve our work if we don't speak up! Use your voice and make it count.

The employee survey is being released to the team leaders on September 5th. This is your opportunity to let the Corporation know how they are doing and whether they have made enough changes from the last survey to make a difference in the work that you do, how you feel, and whether you have the right training and tools to do your jobs.

This is your opportunity to:

- Share your experiences (good, bad, or indifferent)
- Voice your opinion, what works and what doesn't
- Make some suggestions on how they can make things better
- ✓ Be Heard

Your HONEST answers and feedback will make your jobs better as the Corporation uses the survey to make improvements and to know where to focus their attention. This is your workplace and the decisions that are made about your job can impact you. If you don't bring issues forward then you can't get them resolved, this only makes things worse, not better. It is not easy to raise issues, and when you do, often times they are not heard, or the people that you are raising the issues to may not have the ability to make the necessary changes to fix them.

The survey is your opportunity to have your say, voice your concerns, with the right audience, so that if something is broken and not working it can be looked at and be fixed or improved. Alternatively, it also works for the good things as well, if there is something that you like then let them know so it doesn't get changed or removed.

Canada Post needs to know what you are thinking and how you are feeling so they know how to make things better. Give specific examples that can back up your opinion and demonstrate why the change is needed and provide suggestions on how to make it better, as this will help them better understand the issues and make the necessary change to make things right.

Your answers can impact company policy, processes, how you do your job, as well as having the right tools, time, and work environment. Take the time to answer each and every question thoroughly and thoughtfully and avoid rushing through it or just saying what you think they want to hear, as this won't help anyone.

The higher the response rate means that more voices will be heard, data will be more accurate, and results will be more meaningful and tailored to employee needs and concerns. A win-win for everyone!
