**From AccessHR:**

*When employees are eligible for benefits, they are automatically enrolled with single coverage, and they have to fill out the paperwork to change their plans from single to family and also fill in the dependent information form. Once the benefit forms are received in AccessHR, we change their coverage from single to family and it feed over to Canada Life (twice a month). The dependent information form goes to Canada Life directly, so they know who the employee has coverage for on their plans.*

*The forms are in the new hire zone (link) that is sent to the employees. As for the benefit card, this is sent to the employee by Canada Life directly.*

Health and safety and Mental health are big concerns. Know your limits and if you need any help please reach out.

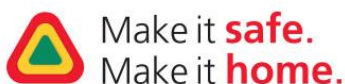
Please continue Submitting weekly NDM to your superintendents. NM is a prime product; continue completing Bunker checks and your on-street Observations.

The Corporation presented APOC with a proposal to change the start times of our work schedules. This affected a majority of APOC members working at Gateway East plant and the TCR office.

The Corporation did not follow the process outlined in Article 13.6 in collective agreement. The Gateway APOC Membership were left in the dark. There were rumours on ongoing talks about a major change in schedules. While CUPW had all the information, the APOC ranks were not fully informed in a timely manner. The lack of clarity and guidance created confusion and left the members hanging, not knowing exactly what was going on.

Our members however are not aware about the resistance the York Branch executives put up to try to stop the Corporation from changing the start times. I personally visited all shifts, and all your concerns and challenges were documented. The Divisional Vice President, Dawn Gayle explicitly informed the Corporation about our concerns. Unfortunately based on the current collective agreements both CUPW and APOC executives could not stop the Corporation despite all the complaints and very serious concerns raised. The impact of this multifaceted change is going to affect the members and their families significantly in many ways.

The Corporation assured APOC that it was willing to accommodate members affected. It is up to individual members affected to raise their concerns and submit their accommodation request forms to their team leaders and managers. Please let me know if you are having any challenges with you accommodation request.

For the members who had concerns about the Night workers leave and earning credits with their shift times being changed. The Collective agreement states that members are entitled to earn night recovery credits when the majority of their hours are on the midnight shift. The midnight shift is defined in the CA as hours between 23:00 to 07:00. **With the members moving to 1:00 to 9:00, (6) six of their hours are still during the midnight shift so they will still be eligible to earn and use their night recovery leave credits.**

The current economic situation in the country with the inflationary pressures is affecting the cost of leaving. Some members are surprised APOC gets zero percent (COLA) cost of living allowance despite the rise in interest rates and the rising cost of everything. APOC members feel that the association leaders have left them down. Are we not all working for the same corporation.? What is the APOC national doing about these issues? How can we collectively influence change?

The APOC York Branch executives cannot do it alone. At the least APOC should have a clause that enables us to get what CUPW gets or better. If we want changes in the collective agreement, then this is the time. We should not seat dormant. Send your concerns on what changes are crucial for the association to the national executives so it can be tabled for the next collective agreement.

The next York Branch general membership meeting is on November 19, 2023. This is the right time to get together and unite to support our local and national executives.
